#### ARCHITECTURAL DESCRIPTION:

Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community.

25 Upland Road (CON.1212) is a two-story wood-frame Dutch Colonial Revival style residence constructed during the first quarter of the twentieth century. The three-by-two bay building faces north and is set back approximately twenty feet from the road on a level lot. The building adopts a rectangular plan on a rubble-stone and concrete foundation. Typical of the Dutch Colonial Revival style, the residence is capped by a side gable gambrel roof. The roof is sheathed with asphalt shingles. A nearly full-width shed roof dormer is located across the north roof plane. Centered on the dormer is a paired 6/6 double-hung wood sash flanked by larger 8/8 double-hung wood sash. An interior end brick chimney pierces the east elevation. The residence is clad with wood clapboards. Access to the residence is provided by a centrally located entry marked by a one-story entry porch. The six panel wood entry door is highlighted by eight-light sidelights. The entry porch features a gable roof supported by slender wood columns resting on a wood deck. The underside of the entry porch roof is curved, a common Colonial Revival detail. A tripartite window comprised of a 6/6 flanked by 4/4 are located to each side of the entry porch. Each opening is set within a simple wood surround. A two-story wing projects out from the east elevation and a one-story rear ell projects out from the south elevation. The wing on the east elevation was originally one-story with the second story added ca. 2010. A one-and-one half story, two-car garage is located west of the residence. 25 Upland Road is a well preserved Colonial Revival residence constructed in Concord during the early twentieth century.

#### HISTORICAL NARRATIVE

Upland Road developed on the edge of the 19<sup>th</sup> century village of West Concord in the first half of the 20<sup>th</sup> century. The street was developed by Kennan Damon and his partners in the Riverview Trust and was the first area south of the Assabet River to be subdivided in West Concord. The developers extended Pine Street to the south and largely paid for the construction of the Pine Street Bridge in 1927. The bridge was replaced in 1941.

In September of 1931 John J. Gallagher and his wife, Ethel F. Gallagher, purchased the dwelling on Upland Road from Kennan Damon and the family moved to the house then numbered 10 Upland Road.<sup>1</sup> In 1940 John worked as a corrections officer at the State Reformatory in Concord. Ethel worked as a stenographer for the Veterans Hospital. They had one son, John W. (b. ca. 1925) and one daughter, Ruth (b.ca.1927). In 1987, John W. and Ruth sold the property to the current owners, Nancy N. Kerr and Richard B. Warren.<sup>2</sup>

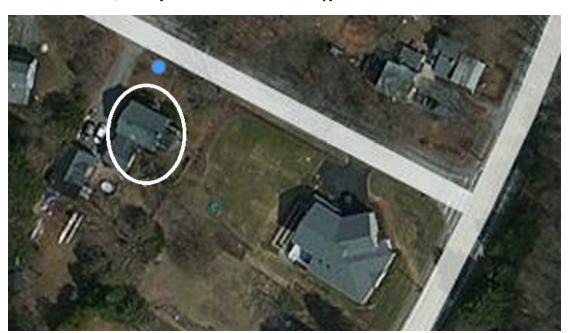

25 Upland Road is a well preserved Colonial Revival residence constructed in Concord during the early twentieth century. The residence possesses a high degree of integrity of design, setting and workmanship. The property meets criterion A and C at the local level and would be a contributing property in a potential Historic District. Upland Road was developed by Kennan Damon and his partners in the Riverview Trust and was the first area south of the Assabet River to be subdivided in West Concord. The developers extended Pine Street to the south and largely paid for the construction of the Pine Street Bridge in 1927. The bridge was replaced in 1941. Many of the homes on Upland Road maintain a high degree of architectural integrity. Boundaries of an Upland Road Historic District would include Upland Road from Old Marlboro Road to Pine Street.
