

Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community.

Probably more than any other building in Concord, this house was built to conform to its site. A hybrid house, it combines the bulk of the Shingle Style with the complexity and inventiveness of form of the Queen Anne. It would be L-shaped in plan in another location; here it follows the triangular edges of the small corner lot to form a unique V-plan. Both of the main sections of the house are gambrel-roofed, their roof planes studded with a variety of dormer types; the west facade also displays a high, wide gable over the main entry. The focal point of the building, however, is the two-story polygonal turret with conical roof, located at the street corner where the wings meet.

Both the Monument Street and Court Lane entries are sheltered by porches that incorporate elements of the Colonial Revival; their balconied roofs are supported on 2/3-length Tuscan columns above a shingled balustrade. The west, Monument Street entry, recessed under the facade gable, has a large glass-and-panel door with a transom and 2/1 sash sidelights. On the south wing, on what was clearly meant to be the minor facade, the entry has a smaller door, with a similar surround. (Cont.)

This house occupies the site of one of the most well-known boarding houses in Concord, which was moved to #30/32 Court Lane in about 1890 by John M. Keyes. In its place he built this as a double house, which had many tenants over the years. The north half was occupied for many years by Miss Louise B. Bigelow, and subsequently by William A. Stevens. For a considerable time at the turn of the century, the tenants of the eastern section were Leonard Metcalf and his mother and sisters, prior to the time that they moved to the old Stedman Buttrick House at # 450 Monument Street. After the Metcalfs left, that "tenement" was occupied by Thompson Stone. Other occupants included Winfred D. Hubbard, civil engineer and Superintendent of the Concord Water Works.

The building was later broken up into six apartments.

ARCHITECTURAL SIGNIFICANCE, cont.

Typical of both the Queen Anne and Shingle Styles, there is a variety of window forms here. The majority, however, are 6-over-2-sash, with molded surrounds. The most elaborate is a large 3-part window in the west facade gable, which is adorned with carved garlands and deeply-molded window crowns. Two polygonal bay windows appear here--a two-story on the south facade, and a one-story on the west, tucked under the deep overhang of the roof.

Other adornment here is minimal, and is concentrated in the molded, boxed cornice, and in the exposed joists and large shingled bracketing under the west roof overhang. One intriguing note, reflective of the whole orientation of the building, is the high T-shaped chimney, set diagonally at the juncture of the two wings.

This house meets the criteria for listing on the National Register as part of a residential district of well-preserved buildings of the nineteenth- to early-twentieth centuries at Concord center. As a large "infill" double-house of the 1890's, it qualifies under Criterion A. As a well-preserved example of a Shingle/Queen Anne building, the only one of its type in the vicinity it also meets Criterion C. It possesses integrity of design, location, setting, materials, workmanship, feeling and association.
